Dr. Fakult's Biography

Dr.Fakult is a licensed physician with 21 years of experience in the fields of internal, urgent care and occupational medicine. She graduated from Case Western Reserve University with an MD degree and worked for University Hospitals of Cleveland prior to joining Concentra in 2011. Initially a Center Medical Director in Willoughby, her responsibility has grown to include oversight of 11 centers in Eastern Ohio and Western PA. She is now the Director of Medical Operations for this region and is a member of Concentra's Travel Heath and Infectious Disease Medical Expert Panel. She loves what she does: Improving the health of America's workforce, one patient at a time.

offering innovative hydration dispensing methods to match whatever challenges you face, was started in 1975 in Columbus, Mississippi when founder Mack Howard had the idea of creating an alternative sports drink that could compete against Gatorade. After consulting with one of his friends, who was a sports trainer, he crafted a new sports drink called Sqwincher.



Q: Could you briefly review storage for compressed gas cylinders?

A: Yes; according to the OSHA Regulations and Ohio Administrative Codes:

Oxygen cylinders in storage should be <u>separated</u> from fuelgas cylinders and/or combustible material (especially oil or grease) a minimum distance of 20 feet or by a noncombustible barrier at least 5 feet high having a fire resistance rating of at least 1/2 hour OAC 4123:1-5-16-(E)(2)(b)(i) / OSHA 29 CFR 1910.253(b)(2)(ii);(4)(iii)

When not in use, cylinders should be **protected** from any excessive heat radiating objects or open flame OAC 4123:1-5-16(E)(2)(b)(ii) / OSHA 29 CFR 1910.253(b)(2)(i)

<u>Close valves</u> on oxygen and acetylene cylinders and bleed off hose pressure after use to prevent damage to regulators and gauges OAC 4123:1-5-16(E)(2)(d) / OSHA 29 CFR 1910.253(b)(5)(ii)(G)

Provide facilities for <u>securely fastening</u> cylinders of compressed gas in an upright position, such as ropes, chains, etc OAC 4123:1-5-16(E)(2)(f) / OSHA 29 CFR 1910.253 (b)(2)(ii); (3)(ii); (5)(iii)(A)

Replace the valve protection cap when a cylinder is not connected for use OAC 4123:1-5-16(E)(2)(c)(ii) / OSHA 29 CFR 1910.253(b)(2)(iv)



Provide check valves and/or flashback arresters on the oxygen and acetylene hoses OSHA 29 CFR 1910.253(e)(3)(ii)(A),(B) & (C)

Except for cylinders that are in use, you should <u>limit the total gas capacity</u> to 2000 cubic feet or 300 pounds of liquefied petroleum gas OSHA 29 CFR 1910.253(b)(3)
